Adjustable straps in short, strong elastic with plastic buckles. Large bib pocket with flap and press studs. Inner pocket with hook and loop band fastening. Adjustable waist. Front pockets. Fly with zip. Reinforced back pockets - one with flap and hook and loop band fastening. Adjustable hammer loop. Thigh pocket with several compartments, flap and adjustable hook and loop band fastening. Pen pockets. Thigh phone pocket with flap and adjustable hook and loop band fastening. Ruler pocket. Kneepad pockets. We recommend 00718-100, 50451-916 and 20118-915 kneepads for this model. Co-certified together with kneepad type LONG in accordance with EN 14404.

- Workwear logo. Right back pocket. Max 10x5 cm/3.9x1.9
- Workwear logo. Horizontal on left thigh. Max 11x5

- Workwear logo. Vertical on right thigh, read from the top downwards. Max 15x5 cm/5.9x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Above bib pocket. Max 12x2 cm/4.7x0.7 inches
- Workwear logo. Horizontal on right calf. Max 12x6 cm/4.7x2.3 inches
