- Extra long zip with storm flap on outside of lower leg so they can be easily pulled on over boots.

### Technical info

Fluorescent with oblique, transverse reflective strips. Two-toned. Breathable, wind and waterproof. Taped seams. Double stitched seams on leg and crotch. Pile lining in body. Lining of quilt in legs and sleeves. Detachable lined hood with adjustable drawstring. Ribbed inner collar. Fastening with zip, storm flap and hidden press studs. Zipped pockets under storm flap. Chest pocket with a zip. Chest pocket with flap and magnetic fastening. D-ring. Pen holder. Front pockets with storm flap. Inner pocket with zip. Ergonomically shaped sleeve pocket. Back pockets with reinforcement, flap and hook and loop band fastening. Thigh pocket with flap and hook and loop band fastening. Ruler pocket. Zip with storm flap on outside of lower legs. Rib (hidden in storm flap) and press stud fastening at cuffs. Products with magnets must not be used by people with pacemakers/ICD or similar devices due to the risk of a magnetic reaction caused where the magnets are placed.

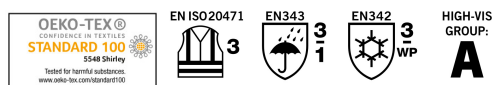

### Logo

The product is certified with maximum 0,8400m<sup>2</sup> logo area. This approved area must not be exceeded. Logo respectively on the front or back of the product, can only constitute a maximum of 50% of the total approved logo area in order to maintain the EN ISO 20471-certification. Note: The listed area is only a guide to how much space is available for logo placement. In order to maintain the product's hi-vis class according to EN ISO 20471, the instructions on logo size must be observed.

### Logo placement:

- Workwear logo. Left breast pocket. Max 7x5 cm/2.7x1.9 inches
- Workwear logo. Mid-back. Max 28x12 cm/11x4.7 inches
- Workwear logo. On the nape. Max 12x5 cm/4.7x1.9 inches
- Workwear logo. On the nape. Max 10x4 cm/3.9x1.5 inches
- Workwear logo. Left back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Right back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Vertical on right thigh, read from the top downwards. Max 25x5 cm/9.8x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Horizontal on right sleeve. Max 10x5 cm/3.9x1.9 inches
