### Technical info

Fluorescent contrast colour and with reflective tapes. Fluorescent part is surface treated, which makes the product dirt-repellent. Two-toned. Triple stitched seams at leg and crotch. Belt loops. Fly with zip. D-ring. Front pockets. Reinforced back pockets - one with flap and hook and loop band fastening. Adjustable hammer loop. Thigh pocket with several compartments, flap and adjustable hook and loop band fastening. Ruler pocket. Thigh phone pocket with flap and adjustable hook and loop band fastening. Pen pockets. Kneepad pockets. We recommend 00718-100, 50451-916 and 20118-915 kneepads for this model. Co-certified together with kneepad type LONG in accordance with EN 14404.

### Logo

The product is certified with maximum 0,0100m<sup>2</sup> logo area. This approved area must not be exceeded. Logo respectively on the front or back of the product, can only constitute a maximum of 50% of the total approved logo area in order to maintain the EN ISO 20471-certification. In order to maintain the product's hi-vis class according to EN ISO 20471, the instructions on logo size must be observed.

- Workwear logo. Left back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Right back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Vertical on left thigh, read from the bottom upwards. Max 25x5 cm/9.8x1.9 inches
- Workwear logo. Horizontal on left thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Vertical on right thigh, read from the top downwards. Max 25x5 cm/9.8x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5

cm/4.3x1.9 inches

- Workwear logo. Horizontal on right calf. Max 12x6 cm/4.7x2.3 inches
